WAYNEEHGOETZ is the Managing Director & Co-Founder at Waygar Capital Inc. Wayne Ehgoetz is considered the pioneer of asset based lending in Canada, having spent more than 25 years in this space. He sits on a number of private and public boards and currently is President of the Commercial Finance Association of Canada. Prior to founding Waygar Capital, Wayne led the asset based lending groups at financial institutions including Standard Chartered Bank, ABN Ambro Bank, Congress Financial as well as Wachovia Bank Canada where he had responsibility for both Canada as well as all international operations. Most recently, Wayne was head of Asset based Lending for Scotiabank where over six years he built the second largest ABL group in Canada. Wayne retired from Scotiabank in 2014 to turn his full time attention to Waygar Capital, a fund he founded five years ago which specializes in asset based loans under \$1,000,000.
